If you have a tax liability with the State of Ohio, you can now receive a 100% tax credit of up to \$750 for individuals filing singly, or \$1,500 for married couples filing jointly, by making a donation to a Scholarship Granting Organization (SGO). Central Catholic has partnered with Every Child Every Family to offer a dollar for dollar tax credit to donors, and uses the funds to provide scholarships to cover tuition for CCHS students in need of assistance. This is a wonderful opportunity to help families who want their children to experience the life-changing education that Central Catholic provides.

# How to Donate to Every Child Every Family and Support CCHS:

Make your check payable to Every Child Every Family and include Central Catholic High School in the memo line. OR donate online at <https://everychildeveryfamily.org/donate/>. Be sure to choose Central Catholic High School as the school to donate to. Please note: If you are married and file jointly, you are eligible to write two separate checks or make two separate online donations up to \$750 each.

Mail checks to: Every Child Every Family, School Choice Ohio, 1335 Dublin Road, Suite 50-A, Columbus, Ohio 43215. Donations must be postmarked by December 31, 2022 to be eligible for a credit on your 2022 tax filing. You will receive a receipt for your gift that you will need to keep for your tax records.

When you prepare your State of Ohio tax return, you can take a tax credit for the amount of your donation!

## Frequently Asked Questions

### *Who is responsible for recording the taxpayer's contribution?*

The SGO (Every Child Every Family) is responsible for acknowledging the taxpayer's contribution. The Scholarship Granting Organization will issue a receipt or other document stating the amount of the contribution, date, and organization's name. The donor must have this document to take the tax credit for the calendar year.

### *What is the maximum tax credit allowed?*

Individual donors to SGOs can take a maximum credit of \$750 per year off their Ohio tax liability. Couples filing jointly can take \$1,500 maximum tax credit as long as their cash donations are in their individual names.

### *What students are eligible for a scholarship through an SGO?*

Schools must give priority to lower income students for scholarships and primarily award academic scholarships for students.

### *Who handles the scholarship applications and awards through Every Child Every Family?*

The application process for Every Child Every Family is managed by the partner schools because they recognize the needs of their students. Central Catholic selects the scholarship winners and determines the amounts of the awards. Once the scholarships are awarded, the school submits the awarded students' applications and proof of income to the SGO.
